MR COOPER CALLED THE MEETING TO ORDER WITH THE FOLLOWING MEMBERS

IN REGARDS TO THE LIQUOR PERMIT REQUEST FOR MARSHALL EUBANKS, DBA
NATIONAL TRAIL COUNTRY STORE, THE TRUSTEES DECIDED TO MAKE A DECISION AT
THE NEXT TOWNSHIP MEETING.

MIKE WILSON GAVE THE FIRE CO REPORT. HE MENTIONED THAT FIRE PREVENTION
WEEK WENT WELL AND THAT ABOUT 800 KIDS WERE ABLE TO GO THROUGH THE
SMOKE HOUSE WHICH WAS DONATED BY THE ZANESVILLE FIRE DEPARTMENT. HE
THANKED CHRIS PRIEST FOR ORGANIZING FIRE PREVENTION WEEK, LES GEORGE
FOR GETTING THE SMOKE HOUSE, MR FYFFE FOR MAKING THE FIRE CO LAMPS OUT
OF
OLD FIRE EXTINGUISHERS, THE TRUSTEES FOR THE BLACKTOP AND STEVE
PATTERSON AND CHARLIE DAVIS FOR PUTTING IN THE GRAVEL HE STATED THAT THE
FIRE CLASS WAS GOING WELL AND THAT THE FIRE CO RECEIVED \$100 FROM JAMES
NEEL AND \$50 FROM JACK SHAFER.

MR COOPER ASKED THAT MR WILSON SEND A COPY OF THE FIRE LEVY FLYER TO RHONDA CARTE SO THAT SHE WOULD BE ABLE TO PUT IT ON THE WEB SITE.

JOE WALKER TURNED IN 4 PERMITS TOTALLING \$390. MR WALKER PATROLLED THE TOWNSHIP AND FOUND ONE VIOLATION WHICH WAS CORRECTED. HE MENTIONED THAT NO CHANGES HAVE TAKEN PLACE REGARDING THE ARBAUGHS COMPLAINT ON RIDGLEY TRACT ROAD AND HE IS STILL CHECKING OUT THE SITUATION ON MARIANNE DRIVE. MR WALKER ALSO MENTION THAT THE ZONING BOARD APPROVED THE VARIANCE ON MAPEL DRIVE. MR COOPER STATED THAT THERE WILL BE A MEETING ON MONDAY

NOVEMBER 25 AT 7:00 P.M. TO DISCUSS THE SITUATION ON RYAN ROAD.

MR COOPER GAVE THE TRUSTEES A COPY OF A LETTER TO THE ENGINEERS OFFICE STATING THAT THE TOWNSHIP WILL TAKE CARE OF THE TOWNSHIP CULVERTS. ALL OF THE TRUSTEES AGREED TO HAVE THE LETTER SENT.

MR COOPER MENTIONED THAT THE LICKING TRAILS ROAD PROJECT WILL COST AN ADDITIONAL \$15330 FOR BANK CHANGES NORTH OF WHITE CHAPEL, A NEW CULVERT ON LICKING TRAILS ROAD SOUTH OF DAVIS DRIVE AND ADDITIONAL TREES TO BE CUT DOWN ON RIDGLEY TRACT ROAD.

A DISCUSSION TOOK PLACE REGARDING THE BERMS AND RESURFACING OF THE TOWNSHIP ROADS. THE TRUSTEES WILL CHECK TO SEE WHERE GRAVEL NEEDS TO BE FILLED IN ALONG THE BERMS.

MR COOPER STATED THAT HE WOULD LIKE TO CONTACT BARBARA EVANS-CASTNER IN REGARDS TO THE OPEN FORUM FOR THE WEST NILE VIRUS SO THAT WE ARE NOT WAITING UNTIL SPRING TO MAKE A DECISION.

MR COOPER GAVE THE TRUSTEES, CLERK AND ROAD CREW INFORMATION REGARDING THE CEMETERY RULES. HE WOULD LIKE TO HAVE ALL INPUT AT THE NEXT MEETING.

IN REGARDS TO THE WELL CASING ON THE CORNER OF LOGAN AVENUE AND COSHOCTON AVENUE, MR ACORD STATED THAT IT IS ON PRIVATE PROPERTY AND THAT THE TOWNSHIP IS NOT LIABLE.

MR ACORD MADE A MOTION TO ADJOURN THE MEETING SECONDED BY MR MILLER.
