

Minutes of the Board of Licking Township Trustees, Regular Meeting, held at the Township Hall Jacksontown, OH at 7:00 pm on November 7, 2005.

Mr. Miller called the meeting to order with the following members present: Dave Miller, Ron Acord, Joe Cooper and Jill Linn.

Others present: Joe Walker, Mike Briggs, Richard Cash, Bonnie Corder-Price, Sheila Lyons, Steve Patterson and Charlie Davis.

The Pledge of Allegiance was recited.

Attached is a copy of all expenditures totaling \$84,828.61.

Minutes of the August 15, 2005 were read approved and signed by the Trustees.

Minutes of the October 3, 2005 were read approved and signed by the Trustees.

Minutes of the previous meeting were read, approved, and signed by the Trustees.

4. Received a SBC Application to install wire on Sandpiper Drive.

Mr. Miller made a motion to accept the SBC application. Mr. Acord seconded the motion. Roll call: Miller, yes; Acord, yes; Cooper, yes.

Mike Briggs gave the Fire Co. report. He mentioned that he had no numbers but he believes that the Fire Co. has surpassed last year run numbers. Mr. Acord made a motion to accept the volunteer application for Angela Collins-Haviland. Mr. Miller seconded the motion. Roll call: Miller, yes; Acord, yes; Cooper, yes. Mr. Briggs mentioned that the tower will be up soon and that the fuel tank has been put on the back burner due to the computer problems.

Mr. Cooper mentioned that Mike Harris was able to save most of the information from the computer at the Fire Co.

Mr. Walker turned in 5 permits totaling \$700. He mentioned that Mr. Marshall has six months to have the old house removed. The sign across from the Golf Works has been removed. The trash problem on Lancaster Avenue and the yard problem on Edgewater Beach Blvd. had been cleaned up. The situation at 85 Wildwood is tied up in probate. The complaint from a resident in Harbor Hills is being worked on. The resident on St. Rt. 13 will be moving the carport back 30 feet from the right of way and Mr. Walker will be issuing him a permit.

Richard Cash mentioned that he and the other residents appreciated the help that Mr. Walker did in getting the resident to take care of the yard on Edgewater Beach Blvd.

Mr. Miller received a call from Mr. Groves who wondered why there was not a Trustee at the Buckeye Lake meeting last Tuesday night regarding a new housing development in the Bounds Addition. Apparently, Mr. Groves is upset that a boat ramp will be put in which will take away some of the boat docks. Mr. Miller mentioned that ODNR is responsible for the boat ramps and that there is nothing the township can do since the property is in Buckeye Lake. Mr. Cooper contacted the attorney, Ms. Klema, who is representing the developer of the property which is called the Bounds Farm lies in the Village of Buckeye Lake. Ms. Klema told Mr. Cooper that at this time they have no plans to develop in Licking Township and at this point in time it is their intent to enter the lake area on the south side not on the east side. Mr. Cooper passed this along to Mr. Groves. Mr. Cooper also mentioned that he asked Ms. Klema to inform Licking Township if they do decide to develop in the township. She said that she would.

Mr. Cooper mentioned that the audio recording equipment is up and running. He also mentioned that we should follow through with Mr. Millers' suggestion as to purchasing a locked cabinet to store the equipment in.

In regards to the DeBevoise property, Mr. Cooper has not heard back from Mr. Cormican as to whether he is able to mow the property. Mr. Cooper contacted Les George to see if he is able to mow the property in which Mr. George said that his equipment is not able to do the job. The Trustees will wait to do anything until they hear from the Prosecutors' Office since there was a question concerning the property.

Mr. Miller mentioned that Mike Riley needs to clean up the mess left from painting the Township Hall. Mr. Cooper will contact him.

Mr. Cooper mentioned that Robert Snedden will send in his receipts for reimbursement for supplies he purchased to fix his yard. The clerk informed the Trustees that the sale's tax will not be reimbursed.

Mr. Cooper asked the Trustees to think about items that should be on the website to improve it.

Mr. Miller mentioned that the dump truck will need a new battery. He also discussed equipment maintenance.

A discussion took place regarding Kirby Lane ditch.

Mr. Cooper mentioned that both zoning boards will be at the next meeting.

Mr. Cooper prepared a letter to Richard Staats for delivering five volumes of the daily ledgers of the L.E. Crows General Store that was located in Jacksontown.

A discussion took place regarding the township records.

Mr. Miller reminded that Township to remember Veterans Day.

Richard Cash reminded everyone to vote.
