Motion was made by Mr. Miller, seconded by Mr. Acord that the attached list of bills be approved as the lawful obligation of Licking Township and the Clerk be directed to issue warrants of the Township in payment of the same. Roll call: Miller, yes; Acord, yes.

Mike Wilson gave the Fire Co. Report. There were 74 runs for the month of August. The Fire Co. received \$1000 on the sale of the water truck. Dave Love passed the medic test. The Fire Co. was granted asked the Trustees for permission to send Richard Gethin and Rhonda Harris to medic school which will cost around \$4000 per person. Mr. Acord made a motion to send Richard Gethin and Rhonda Harris to medic school using the \$7000 grant. Mr. Miller seconded the motion. Roll call: Miller, yes Acord, yes. The Fire Co. is working on the Haunted House. The Fire Co. received a \$237,500.00 grant for a new fire truck. Mr. Acord made a motion to have Mr. Wilson get together the information needed so that they can bid for a new fire truck. Mr. Miller seconded the motion. Roll call: Miller, yes; Acord, yes.

Mr. Walker turned in 2 permits totaling \$195.

Mr. Miller made a motion to accept the request by Rod Wolfe, Kirk Wolfe, and Joy Hildreth for a zoning change from Commercial to Residential for the property located at 41 Delmar Place, Reserve E of Harbor Hills. Mr. Acord seconded the motion. Roll call: Miller, yes; Acord, yes.

Mr. Miller mentioned that the Mr. Sneddens' ditch will be worked on Friday, September 9 and if needed, finished on Monday, September 12.

In regards to the maintenance of the Cartt property, the clerk mentioned that the letter came back. Mr. Acord will call John Cormican and have him mow the property. The amount will be place on the Cartts' tax bill.

The Trustees tabled the discussion for the sound equipment.
