

Minutes of the Board of Licking Township Trustees, Regular Meeting, held at the Fire Co. Station 3, Jacksontown, OH at 7:00pm on June 16, 2008.

Mr. Hart called the meeting to order with the following members present: Joseph Hart, David Miller and Jill Linn.

Others present: Bill Ours, Joe Walker, Robert Snedden, Richard Cash, Marshall Eubanks, Charles Davis, Scott Harmon, Robert Mar, Denise Delagrang, Ben Sarap, Bob Hamilton, Rick Rife, Rhonda Carte, Charles Prince and Steve Patterson.

The Pledge of Allegiance was recited.

Minutes of the May 19, 2008 meeting were approved and signed.

The financial reports were given to the Trustees.

Mr. Miller made a motion to approve the list of bills totaling \$14,336.72. Mr. Hart seconded the motion. Roll call: Hart, yes; Miller, yes.

There are funds on hand or in the process of collection to pay the attached listed bill. _____, Fiscal Officer.

CORRESPONDENCE:

1. Received the June Grassroots Clippings.

There was no Fire Company report.

Joe Walker turned in one permit totaling \$150.

Mr. Miller mentioned the junk property located in Jacksontown. Mr. Walker mentioned that he will look into it and talk to the property owner.

The Trustees went over the list of roads needing to be resurfaced and material to be used. Mr. Hart made a motion to advertise for the road bid. Mr. Miller seconded the motion. Roll call: Hart, yes; Miller, yes.

Mr. Miller mentioned that he talked with Jeff Walker regarding FEMA monies that the township can apply for from the snow storm on March 8 & 9. He will give the information to the Fiscal Officer so that it can be turned in by July 4.

Denise Delagrang read a letter pertaining to the no parking sign in front of her property. Mr. Hart mentioned that he received a complaint of a blocked driveway and after review of the map Mr. Hart and Mr. Miller found out that the road has not been vacated so the decision was made to put up the sign. A discussion

continued regarding the situation. Denise also mentioned the trash in her neighbors' yard. Mr. Hart mentioned that if she believes that there are health issues she will need to file a complaint with the health department. Denise said that someone should have contacted her before the sign was put up. Mr. Hart apologized and said that someone should have contacted her from a professional standpoint. Further discussion took place regarding the parking.

Scott Harmon, whose father lives on Roberta Drive, asked about the drainage. Mr. Hart gave Scott his opinion as to what he should do. After a discussion, Mr. Miller said that if Scott gets the 4" pipe the township will help with the installation.

Robert Snedden asked the trustees how they know how wide the roads are. Mr. Miller mentioned that the county engineer has a map of the roads in the county. Mr. Hart mentioned that in regards to the roads that are being bid they were actual measurements. Mr. Hart mentioned that there would be no comment regarding Somerset Road until the issue of the centerline is determined. Mr. Hart mentioned that he has noticed additional items placed to the edge of the road. Mr. Snedden mentioned that it is private property. A discussion followed.

Mr. Miller mentioned that H.B. 740 will permit the township to enter on private land to remove vegetation that is blocking the sightlines along the township roads.

Rhonda Carte asked about the status of the adobe software. Mr. Hart mentioned that she should talk to Mr. Cooper.

Charles Davis asked how many meeting Mr. Cooper can miss. Mr. Hart said the he can miss as many meetings as he wants but in order not to be a trustee he physically has to be out of the township for 90 straight days and living someplace else.

Robert Mar was asking if there was a parking proposal from the Zoning Commission. Mr. Hart and Mr. Miller both said that they have not seen one. Mr. Hart mentioned that he made a comment at the last township meeting that he was prepared to put together a proposal that could amend the text and Mr. Cooper said that he had asked the Zoning Commission, as a single trustees opinion and not on behalf of the board, as to what they thought the parking should be throughout the township. Mr. Hart believes that as a board, they should apply some common sense to the issue and that there is a field that is available that helps eliminate the problem that most of the neighbors have had and that the township has tired to alleviate but there are other considerations in the township that need to be looked at in terms of parking. Denise Delagrance mentioned that Frank Davis will prepare a statement for the Zoning Commission Board to approve at their next meeting. A discussion followed.

The Trustees signed checks.

Mr. Hart made a motion to adjourn the meeting at 8:45pm. Mr. Miller seconded the motion. Roll call: Hart, yes; Miller, yes.
