

Minutes of the Board of Licking Township Trustees,  
Regular Meeting, held at the Township Hall, Jacksontown, OH  
at 7:00pm on November 16, 2009.

Mr. Hart called the meeting to order with the following  
members present: Joseph Hart, David Miller, John Holman  
and Jill Linn.

Others present: Robert Snedden, Joe Walker, Bill Ours,  
Lloyd Fyffe, Ron Acord, Larry Gerlach, Mike Wilson, Richard  
Cash, John Hower, Rob Mills and Steve Patterson.

The Pledge of Allegiance was recited.

Mr. Hart mentioned that the American Legion along with Mr.  
Miller, conducted a dedication ceremony for the Licking  
County Bicentennial Historical Marker which was placed on  
the Township Hall. It was dedicated to the Licking  
Township Veterans.

The financial reports were given to the Trustees.

Mr. Holman made a motion to approve the expenditures  
totaling \$166,695.44. Mr. Miller seconded the motion.  
Roll call: Hart, yes; Miller, yes; Holman, yes.

#### CORRESPONDENCE:

1. Email from Wally Spence regarding Geocaching.

In regards to the email from Wally Spence, Mr. Hart will  
responded to Wally Spence informing him that it is not  
Licking Township property.

Mike Wilson gave the Fire Co. report. He mentioned that he  
ordered the mattresses from the Original Mattress Factory  
since they had the twin extra long mattresses.

Mr. Hart made a motion to accept the applications for  
Kyle Weekly and Austin Bragg as volunteers for the  
Licking Township Fire Co. Mr. Miller seconded the  
motion. Roll call: Hart, yes; Miller, yes; Holman,

yes.

Mike Wilson thanked the township for supporting the fire levy but had concerns with the no voters. He would like to place something in the paper to say thank you to the yes voters and would like to reach out to the no voters. Mr. Hart said that he can put something together for review.

Mr. Hart mentioned that he drove through the township and thanked Steve and Rob for the berming that they did.

Mr. Miller mentioned that the Shelly Co. went over on their bid by around \$300 because the engineers' office didn't bring the survey equipment and they needed more material on Ridgely Tract Road.

Mr. Miller mentioned that they will be purchasing 20 cones for \$18.50 each plus \$.25 to put LT on the cones. Mr. Miller will order the cones through Bill Ours.

Joe Walker turned in one permit totaling \$50.00. Ronell Vickers property has been mowed. There will be a BZA meeting on Wednesday.

Mr. Hart mentioned that he received a call from a lady on St. Rt. 13 who would like to make her property commercial. He told her to contact Joe Walker.

Mr. Miller mentioned that he received a call from a real estate agent who was interested in the property north of Dorsey Mill. He told her to contact Joe Walker.

Mr. Hart mentioned that Robert Snedden has intentionally and deliberately created a nuisance and safety hazard along Somerset Road by placing large stumps and boulders willfully to create a hazard. Mr. Hart prepared a letter to Robert Snedden after his discussion with the Prosecutors' Office. Mr. Hart read the letter which is on file with the Fiscal Officer. The Trustees agreed with the letter and Mr. Miller gave Robert Snedden the letter at approximately 7:35pm. Mr. Hart asked Robert Snedden to remove the items immediately.

As a matter of procedure, there are two resolutions which need to be passed before the new Trustees take office.

Mr. Hart made a motion that the Licking Township

Trustees authorize payment of the required Bonds for Trustees elect Mr. Acord and Mr. Miller with the requirement that they submit the Bonds and a copy of the Oath of Office to the Fiscal Officer no later than January 1, 2010. Mr. Holman seconded the motion. Roll call: Hart, yes; Miller, yes; Holman, yes.

Mr. Hart made a motion that the Licking Township Trustees authorize Trustees elect Mr. Acord and Mr. Miller to participate in the provisions of the Township insurance programs subject to the requirements of section 505.60 of the ORC with the same options currently provided to existing Trustees as of the date they take office. Mr. Holman seconded the motion. Roll call: Hart, yes; Miller, yes; Holman, yes.

Richard Cash mentioned that the engineers' office does make mistakes when putting property line down. Mr. Cash said that he believes that Bob Brown owns the property with the spring. Mr. Hart said that Wally Spence can do his own research.

Robert Snedden mentioned that he did move everything and then the people were driving on his property so how is he supposed to stop them. Mr. Hart said that the stuff needs to be removed. Mr. Hart also said that once the centerline was done our township zoning calls for a 30' right of way, which was in affect when Robert reacquired the property in 2001. Mr. Snedden asked if they were going to anything about the fruit stand and Mr. Hart said that he made it clear at the last meeting that they were not.

John Hower, from Rinehart Insurance represents The Ohio Plan. He went over insurance information. The Fiscal Officer will send in information to get an insurance quote.

Mr. Hart congratulated Mr. Acord and Mr. Miller on the election and thanked Mr. Holman for the time and effort he put in as a Trustee.

Mr. Miller made a motion to adjourn the meeting at 8:05pm. Mr. Holman seconded the motion. Roll call: Hart, yes; Miller, yes; Holman, yes.
